NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 8 of the Hindu Marriage Act, 1955 (Central Act 25 of 1955), the Government of Karnataka hereby make the following rules further to amend the Registration of Hindu Marriage (Karnataka) Rules, 1966, namely: -

RULES

1. Title and Commencement. - (1) These rules may be called the Registration of Hindu Marriage (Karnataka) (Amendment) Rules, 2024.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment to rule 4. In the Registration of Hindu Marriage (Karnataka) Rules, 1966, in rule 4.

(i) in sub rule (1) after the words "or send them by Registered post" the words "or electronically" shall be inserted;

(ii) in sub rule (4) at the end after the words and figure "beginning with figure 1" the words "or stored electronically" shall be inserted; and

(iii) in sub rule (5) after the words "on filing memorandum along with the application" the words "or stored in electronic media" shall be inserted.
