Preamble:

In view of addressing the gap in the implementation of National Oil Spill Disaster Contingency Plan (NOSDCP), with the necessary response structure / organization for handling the oil spill incidents by the Coastal States/Union Territories and as a measure of fulfillment of the obligation of India under the United Nations Convention on the Law of the Sea Secretary (Security), Cabinet Secretariat vide letter referred above have requested to constitute Crisis Management Groups (CMGS) for management of oil pollution incidents at State, district and local levels and to maintain basic pollution response equipment like deflective booms, fence booms, spray equipment along with specialized equipment for beach protection and shoreline clean up and to issue notification.
